Home to over 3 million residents, our customer was a county situated in the Los Angeles metropolitan area in Southern California. Being one of the largest counties in state of California, it serves a variety of social services to its diverse community of residents.

These include public health programs, community-based services, and partnerships with non-profit organizations.

Challenges

One of the largest counties in the state of California faced a challenge in protecting the privacy of its citizens. To improve the quality of its health and human services and gain valuable information about caller satisfaction, the county considered using an experience management platform to analyze call recordings.

However, the challenge came when the county government realized the calls contained Personally Identifiable Information (PII) like names, phone numbers, social security numbers (SSNs), etc. That meant the recordings could not be shared with third-party providers outside of the state due to California's stringent data privacy regulations like the CCPA and CPRA.

The only way to proceed was to ensure that all PII was redacted from the call recordings before they left the state's possession. This required a solution that could effectively identify and remove sensitive information from the recordings while preserving their value for analysis.

But to do that, the solution needed to do two things. One, it needed to be able to redact a large volume of calls, given that the county receives 1.1 million call recordings per year. Two, it needed to be installed within the county's four walls so that no PII left the jurisdiction.

Solution

VIDIZMO Redactor, a cutting-edge Al-powered redaction software, proved to be the ideal solution for this unique challenge. With its advanced capabilities and flexibility, VIDIZMO Redactor met the county's specific requirements and addressed the critical need for data privacy and security.
